PRIVACY POLICY

The Website and its operator, Gosford Quarries Pty Ltd (ACN 002 005 629) ("GQ" or "We" or "Us"), are committed to protecting your privacy. We are committed to complying with the Australian Privacy Principles in the Privacy Act 1988 (Cth) and any obligations we may have under the EU's General Data Protection Regulations ("the GDPR"). GQ aims to provide the best possible service on the Website. To achieve this aim, we need to make the most efficient use of all personal information that is provided by you to us on a confidential basis.

Please read this Privacy Policy carefully before you submit any information through the Website as usage of this Website is conditional on your agreeing to be bound by this policy. If you have any questions, or would like to provide feedback, please feel free to contact us on the number or address listed below.

The information practices of the Website

1. What is personal information?

Personal information *or personal data* is any information about you that identifies you, or by which your identity can be reasonably determined. *In this policy we refer to both as personal information*.

2. Collecting information about you

Some services provided through the Website require your email address and may involve disclosing some personal information about yourself. This is to allow Us to respond to a query or provide you with information that you have requested. You will also have the option to provide other personal information voluntarily.

We need this personal information to enable Us to respond to a query or provide you with information that you have requested. You will also have the option to provide other personal information voluntarily. When collecting your personal information, we take reasonable steps to make you aware of the purposes for which the information is being collected by us. We will only use or disclose your personal information for the purpose for which we collect it, and for related purposes that we consider

are within your reasonable expectations.

We may also collect information about your use of the Website from a computer, mobile phone or other device, such as what pages you visit, documents you download, the Internet address you have come from, your server's address, domain name, date and time of visit. Otherwise, we will seek your consent prior to using or disclosing your personal information for another purpose, unless we are required or authorized by law to do so without seeking your permission.

By having this information, We can tailor your experience of our Website to your personal interests. We will take reasonable steps to destroy your personal information when it is no longer needed by us.

3. Using your personal information

Any personal information collected by Us will be treated as confidential. We may use your personal information in providing you with information or services you request, and in tailoring your experience of our site to your interests.

We may also use pooled information obtained from all Website visitors to understand our users' interests and improve our services. These reports may be shared with the partners and sponsors of the Website but they will not disclose personally identifiable information.

4. Disclosure

We will not disclose any of your personally identifiable information, except when it has your permission or under special circumstances, such as when we believe in good faith that the law requires disclosure or where we believe it necessary to provide you with a service that you have requested.

5. Other Online Services

If any of our online services (including any e-mail messages we send to you) contain links to the other online services that are not maintained by us ("Other Services"), or if Other Services link to our online services, we are not responsible for the content of those Other Services or the privacy practices of the organisations that operate them, and by providing such links we do not endorse or approve the Other Services. This Privacy Policy applies only in respect of our online services.

6. Direct Marketing

We will not use your personal information to provide you with any information on any issue or service we may think you would be interested in. At GQ we do not engage in any form of direct marketing for the Website.

We do not disclose your personal information to any parties outside GQ for the purposes of allowing them to direct market their products or services to you.

7. Disclosure of Personal Information to Third Parties

The Website may disclose your personal information in certain circumstances.

Like many businesses, the Website uses a range of service providers to help us maximise the quality and efficiency of our services and our business operations. This means that individuals and organisations outside of the Website, such as Web hosting services, will sometimes have access to personal information held by the Website and may use it on behalf of the Website. We require our service providers to adhere to strict privacy guidelines and not to keep this information or use it for any unauthorised purposes.

8. Our Website privacy practices

We sometimes use cookie technology on our Website to enable us to provide information and services to Website visitors. Cookies are pieces of information that a Website transfers to your computer's hard disk for record keeping purposes and are a necessary part of facilitating online transactions. Most web browsers are set to accept cookies. The Website uses cookies to make your use of our Website and services as enjoyable as possible. Cookies in and of themselves do not personally identify users, although they do identify a user's browser. Cookies are useful to estimate our number of members and determine overall traffic patterns through our Website, as well as responding to your requests for particular services.

If you do not wish to receive any cookies you may set your browser to refuse cookies. This may mean you will not be able to take full advantage of the Website services.

9. Storage

The Website will endeavour to take all reasonable steps to ensure your personal information is kept secure, accurate and up to date. Your information is stored on secure servers that are protected in controlled facilities. Unfortunately, no data transmission over the Internet can be guaranteed to be 100% secure.

We cannot give an absolute assurance that the information you provide to Us will be secure at all times. You accordingly do so at your own risk and We will not be held responsible for events arising from unauthorised access to your personal information.

10. Security of Your Personal Information

We endeavour to take all reasonable precautions to safeguard personal information from loss, misuse, unauthorised access, modification or disclosure. The precautions we take include:

external and internal premises security;

restricted access to personal information;

confidentiality agreements with contractors and third-party organizations;

maintaining technology products to prevent unauthorised computer access.

11. Data Transfer

We are an Australian-based company and your personal information will be collected, processed and

accessed in Australia. Your personal information may, however, be stored outside of Australia,

depending on the data management processes of the third-party cloud-based services to which we

subscribe (i.e., Zoho CRM, Mailchimp, Google Analytics). Australia has its own laws governing data

protection and government access to information. The rules that protect your personal information

under Australia law may be different than in your home country.

12. Ensuring your personal information is to update
